Patients with Advance Directives/Living Will

It is the policy of the UPMC Hamot Surgery Center NOT to honor a "No Code" request, aka DNR ("Do Not Resuscitate") request. Anesthetic agents and/or medications have the potential for causing a cardiac or respiratory arrest that is temporary and reversible. Resuscitative efforts will be implemented on any patient experiencing a life threatening event while in the operating room or recovery area. In the unlikely event there is a complication, you will be transferred to the hospital where the hospital's policy on Advance Directives will be followed. Questions about this policy may be directed to the attending physician or anesthesiologist.
