The Summit Township Planning Commission regular business meeting was called to order by Chairman Tim Will at 7:04 p.m., followed by a salute to the flag. Present were Board Members, Christian Green, Ronald McElderry, Bill White, Charles Knight, and Alternate Tracey Colvin. Also present were Engineer Matthew Jonas, Zoning Administrator Nathan Miller, Administrative Assistant Tamara Cass and 4 interested members of the public. Board Member Joel Brennan and James Andrus were absent from the meeting.

Jim Welka, of Henry T. Welka & Associates, was present on behalf of the Eldaberry Woods Phase 2 Subdivision Plan, Parcel ID No. 40-19-83-36.04, In-part, A-1 (Agricultural). Welka explained the proposed subdivision plan shows the existing 54.99 acre lot divided into three (3) separate parcels as Phase 2 on New Road. The proposed Lot 3 would become 2.739 acres of vacant land and the proposed Lot 4 would become 2.742 acres of vacant land. The residue Parcel would become 49.485 acres of vacant land. Welka also stated that the Wasielewski's are aware that the 20' sanitary easement currently exists on both lots of record, as they have worked with the sewer authority to have the sewer extended as depicted on the plan. The Wasielewski's are proposing to subdivide these lots for the purpose of single-family dwelling development lots. Knight asked if the potential buyers would be aware of the environmental issues that may arise from the extensive wetland areas. Welka stated that the wetlands are depicted on the subdivision plan so that they are easily identifiable by prospective buyers.
