Andrew Halmi, of Deiss & Halmi Engineering, Inc. was present on behalf of the Quality Mold, Inc. Land Development Plan, 8130 Hawthorne Drive, Parcel ID No. 40-017-073.0-019.14, IP (Industrial Park). Halmi explained that the land development plan consists of a proposed 7,200 sq. ft. industrial building addition to the existing Quality Mold industrial facility with associated parking and an updated stormwater system. McElderry asked if all the Engineer's comments were addressed in the letter he sent. Halmi stated he had replied to most of the comments and will make the changes on the Land Development Plan. Zoning Administrator Miller asked where they were planning on placing the enclosed dumpster. Halmi noted they plan on placing the enclosed dumpster just off the southeastern corner of the existing building. Tracey asked if employees would be parking in the unloading area. Halmi responded they will not be parking in the unloading area, as the employees will be utilizing the parking area in the front lot on the northwest side of the building.

Engineer Jonas discussed paving and improvements on Peach Street which is included in our seven-year master plan for the township. Jonas stated the first phase would be an overlay on Mandy Lane and Keystone Drive. He is also pushing to get updated signals on Rotunda Drive. Zoning Administrator Miller commented that we have been working with Penelec and other property owners to possibly remove some old paper street right-of-ways along Perry Highway and Old Perry Highway.

Miller noted that they will have to officially amend the transportation plan in order to reflect the recommendations of the Comp Plan, but we don't want to do that until the old right-of-ways have been officially removed so that we only have to amend the transportation plan once. When the step of removing the right-of-ways is completed we would then present the proposed amended transportation plan to the planning commission for their recommendation. Miller also stated that the Supervisors think we should continue to work with EPD (Environmental Planning and Design) for our future Zoning Ordinance changes.

With no other business to come before the Board, motion was made by Friday, seconded by McElderry to adjourn the meeting at 7:17 pm.
