Motion by Welka, second by Davis, to approve Resolution #2021-07, Intergovernmental Agreement with Millcreek Township for resurfacing of South Hill Road. Supervisor Lee explained that Millcreek will be paying for materials to resurface S. Hill from Washington to Kuntz Rds and we will be performing the work.

Motion by Davis, second by Welka, to approve expenses for M. Jonas and J. Whitmer to attend and obtain drone certification. Mark Sleppy questioned the need for the expense of \$434 per person. It was stated that drones can assist with topographic mapping, road, and culvert inspections, and can be married into our existing GIS system. Currently we are paying approximately \$5000-\$6000 per topo survey, outside companies charge more than \$275/hour for flying our boundaries – this is an investment in the future.
